- Purpose of collection and use: Receipt of donations through CMS direct debit, Operation of Donor Courtesy Program
- Information Gathered: Name, date of birth, mobile phone number, email address, bank name, name of account holder, account number, signature, address, alumnus information
- Retention and period of use: From the date of consent to gathering and use until five years after the direct debit is cancelled
- Applicants have the right to reject the gathering and use of personal information. However, if they do so, the direct debit application may be rejected.
- Parties to which personal information is provided: Financial institutions such as the Korea Financial Telecommunications and Clearings Institute and a range of banks
- The resident registration number is processed for the purpose of determining donation receipt issuance specifications and of issuing these receipts for the purpose of year-end tax settlements. (Based on Article 113 Paragraph 1, Article 208-3, etc. of the Enforcement Decree of the Income Tax Act)
